| 1. A-1 is fouled and entitled to two free throws. The official indicates a one and one. The first attempt is unsuccessful and rebounded by B-2, who passes the ball to B-3. The error is discovered with Team B in control. The official rules A-1 will receive the merited free throw with players occupying the marked lane spaces and play will continue from the make or miss. Is the official correct? | 1. | Yes | No |
| 2. A-1, while in the act of shooting, is fouled but time expires before the ball is released. The try is successful. The official disallows the goal and awards A-1 two free throws. Is the official correct? | 2. | Yes | No |
| 3. A-1’s throw-in is deflected by B-2. Prior to either team gaining control inbounds, A-2 fouls B-2. Team B is in the bonus. The official rules a team control foul. Is the official correct? | 3. | Yes | No |
| 4. A-1 dribbles the ball off a B-1’s foot causing A-1 to lose control. When A-1 gets to the ball, A-1 catches the ball with both hands and begins another dribble. The official rules an illegal dribble. Is the official correct? | 4. | Yes | No |
| 5. While Team A has the ball out of bounds for throw-in, A-2 commits a common foul on B-2. The official rules a team control foul. Is the official correct? | 5. | Yes | No |
| 6. A double personal foul is committed in the low post while A-1 is dribbling near the division line. The official awards the ball back to Team A nearest to where the ball was located. Is the official correct? | 6. | Yes | No |
| 7. After the ball is released during an alternating possession throw-in by A-1 and before the ball is touched by either team, A-2 commits a common foul on B-2. The official awards the ball to Team B and instructs the scorer to turn the arrow in favor of Team B. Is the official correct? | 7. | Yes | No |
| 8. A-1, while dribbling in the frontcourt, has the ball batted away and the ball rolls into the backcourt. The official begins the 10 second count when the ball touches the floor in backcourt. Is the official correct? | 8. | Yes | No |
| 9. B-1 has obtained a legal guarding position when A-1, while driving to the basket, causes contact shoulder to shoulder with B-1. The contact does not affect B-1’s ability to play but A-1 falls to the floor. The official rules this incidental contact. Is the official correct? | 9. | Yes | No |
| 10. Prior to A-1 releasing the ball on his/her free throw, B-1 steps into the lane. The official inadvertently sounds the whistle. The official re-administers the free throw which is unsuccessful. The official allows play to continue. Is the official correct? | 10. | Yes | No |
| 11. The possession arrow favors Team B to start the second quarter. Prior to the ball becoming live, a technical foul is charged to Team A. Following the free throws, Team B inbounds the ball and a held ball occurs. The official awards the throw-in to Team A under the alternating possession procedure. Is the official correct? | 11. | Yes | No |
| 12. Thrower-in A-1 fumbles the ball onto the court. A-1 recovers the ball while still out of bounds and completes the throw-in. The official rules a legal play. Is the official correct? | 12. | Yes | No |
| 13. As A-1 is dribbling to the basket, B-2 jumps in front of A-1, has both feet on the court and is facing A-1 just before A-1 contacts B-2 in the torso knocking B-2 to the floor. B-2 does not give A-1 time or distance to change direction. The official rules a blocking foul on B-2. Is the official correct? | 13. | Yes | No |
| 14. A-1 is charged with his/her second technical foul. After the official notifies the coach that A-1 is disqualified, A-1 directs profanity toward the official. The official charges A-1 with another technical foul and an indirect technical foul to the head coach. Is the official correct? | 14. | Yes | No |
| 15. A-1’s throw-in hits an official. A-1 returns to the court and is the first to touch the ball. The official rules a throw-in violation. Is the official correct? | 15. | Yes | No |
| 16. With three-tenths of a second remaining in the game, A-1’s throw-in is caught by A-2, who is fouled as he/she throws the ball toward his/her basket. The foul occurs before the signal sounds indicating time has expired. Team A is in the bonus. The official awards A-2 a one and one. Is the official correct? | 16. | Yes | No |
| 17. A-1 has the ball out of bounds for a designated spot throw-in. After A-1 releases the ball, B-1 reaches through the boundary line and intercepts the ball. The official rules this a legal play. Is the official correct? | 17. | Yes | No |
| 18. During A-1’s interrupted dribble, a double personal foul is committed. The official awards the ball back to Team A. Is the official correct? | 18. | Yes | No |
| 19. As the official is ready to place the ball at A-1’s disposal for the throw-in, he/she notices Team A has six players on the floor. The official assesses Team A with a technical foul. Is the official correct? | 19. | Yes | No |

20. Yes No 20. While B-1 has the ball for a throw-in following a field goal by Team A, Team A is issued a warning for breaking the plane of the boundary line. The official rules that Team B may move along the endline. Is the official correct?
21. Yes No 21. A-1 and B-1 collide and both players are bleeding. The official stops the game and directs both players to the bench. Team A takes a time-out. Following the time-out both players enter the court ready to play. The official allows both players to resume playing. Is the official correct?
22. Yes No 22. A-1 is fouled while in the act of shooting and awarded two free throws. The first free throw is missed and the official allows the ball to remain in play. B-1 rebounds the ball and then commits a violation. The official now recognizes A-1 should have been given another free throw. The official awards A-1 his/her second free throw with no players along the lane and resumes play from the point of interruption. Is the official correct?
23. Yes No 23. Team A is awarded the ball to start the second half. Team A commits a throw-in violation. The official instructs the scorer to turn the possession arrow toward Team B's basket and awards Team B the ball. Team B commits a throw-in violation. The official awards the ball to Team A and has the scorer turn the arrow toward Team A's basket. Is the official correct?
24. Yes No 24. A-5 attempts to dunk the ball. The ball slips out of his grasp on the way up and enters the imaginary cylinder above the basket. A-5 momentarily grabs the ring to protect himself and then releases the ring. While the ring is returning to its original position, the ball passes through the goal without contacting the ring. The official rules basket interference. Is the official correct?
25. Yes No 25. Just as the official is tossing the ball for a jump ball, B-1 commits a violation. A-1 then taunts B-1 and is charged with a technical foul. Following the free throws, Team B is awarded the ball for a throw-in at the division line opposite the scorer's table. When the official places the ball at the disposal of Team B, the official directs the scorer to set the arrow toward Team A's basket. Is the official correct?
26. Yes No 26. A-1 is dribbling the ball when B-1 reaches in and commits a common foul against A-1. Team A is in the bonus. After the whistle A-1 shoves B-1 and the officials rule an intentional technical foul. The officials award A-1 his bonus free throw attempt with no players along the lane. Team B is then awarded two free throws for the intentional foul and the ball is awarded to Team B at the division line opposite the table. Were the officials correct?
27. Yes No 27. While A-1's pass is in the air toward A-2, A-3 and B-3 commit a double personal foul. The official resumes play using the alternating possession procedure. Is the official correct?
28. Yes No 28. Team A submits its squad list and starting lineup at least 10 minutes before the game. After the 10 minute mark, the coach adds two names to the squad list and Team A is assessed a technical foul. During the first time-out the officials are notified that two Team A players are wearing different numbers than those listed in the official scorebook. The official assesses another technical foul to Team A. Is the official correct?
29. Yes No 29. With the score tied, A-1's try is touched by B-1 on its upward flight when the signal sounds indicating time has expired in the game. The ball enters the basket. The official counts the basket. Is the official correct?
30. Yes No 30. Coach of Team A is charged with an indirect technical foul. The official instructs the scorer that that foul counts as a team foul to reach the bonus. Is the official correct?
31. Yes No 31. The ball is loose on the floor while Team A is in control. A-1 commits a common foul on B-2. Team B is in the bonus. The official rules a team control foul. Is the official correct?
32. Yes No 32. Before the bonus is in effect and while the ball is in flight during a field goal attempt by A-1, A-2 fouls B-2. The try is successful. The official rules Team B's throw-in is a designated spot throw-in. Is the official correct?
33. Yes No 33. Team B scores and is granted a time-out with three seconds remaining in the game. Following the time-out Team A is awarded the ball for the throw-in anywhere along the end line. A-1 passes the ball to A-2 along the end line. A-2 passes it to A-3 running the length of the court. The timer mistakenly starts the clock when A-2 touches the ball. The official notices the clock is running as soon as A-3 catches the ball. The official stops play and has the three seconds put back on the clock and awards Team A the ball where A-3 caught the ball. Is the official correct?
34. Yes No 34. Players are attempting to rebound the ball at A's basket. While trying to secure the ball, B-1 accidentally bats the ball towards A's basket. Time expires while the ball is in flight. The ball passes through the basket. The official counts the goal. Is the official correct?
35. Yes No 35. A-1 is being closely guarded by B-1. While the official is counting the 5 seconds, A-2 moves between A-1 and B-1 and remains there. The official discontinues the count. Is the official correct?
36. Yes No 36. Following a successful field goal, Team B has the ball out of bounds for a throw-in when A-1 commits a common foul on B-2 near the endline. Team B is not in the bonus. The official allows Team B to move along the end line. Is the official correct?
37. Yes No 37. A-1 commits his/her fifth foul but the scorer fails to inform the official. As soon as the scorer discovers the error, he/she notifies the official and A-1 is removed. The official rules any points scored by A-1 during this time count. Is the official correct?

| 38. Prior to A-1 releasing the ball on a free throw, B-2 enters the lane followed by A-2. Both are in marked lane spaces. A-1's free throw is unsuccessful. The official penalizes only B-2's violation and awards A-1 a substitute free throw. Is the official correct? | 38. Yes | No |
| 39. Thrower-in A-1, from the frontcourt endline, throws the ball into the backcourt. A-2 is the first to touch the ball in backcourt. The official rules a legal play. Is the official correct? | 39. Yes | No |
| 40. During a throw-in Team B is issued a warning for breaking the plane of the boundary line. Before the official is ready to resume play, a substitute reports to enter the game. The official denies the substitute from entering the game. Is the official correct? | 40. Yes | No |
| 41. A-1 dives for a loose ball and slides on the floor. Prior to stopping A-1 rolls over onto his/her back. A-1 then sits up. The official rules a legal play. Is the official correct? | 41. Yes | No |
| 42. After the horn has sounded to start the second half, Team B is on the floor ready to play. Team A continues to huddle. The official uses the resumption of play procedure to resume play. Is the official correct? | 42. Yes | No |
| 43. One official rules a block and the other official rules a foul on the airborne shooter. The ball enters the basket. The officials rule a double personal foul, disallow the basket and use the alternating possession procedure to resume play. Is the official correct? | 43. Yes | No |
| 44. Prior to the first free throw by A-1, Team A chooses not to occupy the second marked lane space. B-2, who is occupying third marked lane space, moves into the second marked lane space. The official rules this legal. Is the official correct? | 44. Yes | No |
| 45. After A-1 releases the ball on his/her free throw and before the ball hits the ring or backboard, B-1 steps into the lane to box out A-1 and steps across the free throw line. The try is unsuccessful. The official rules a violation and awards A-1 a substitute free throw. Is the official correct? | 45. Yes | No |
| 46. Team B is issued a warning for interfering with the ball following a goal. Later in the game, Team B commits a violation by breaking the plane of the boundary line before the ball is released. The official rules there is no penalty because the violations were different infractions. Is the official correct? | 46. Yes | No |
| 47. A-1 is awarded a one and one, but the official erroneously states two free throws. A-1's first attempt is missed and rebounded by A-2, who scores while the other players make no attempt to rebound the ball. The official now recognizes the error. The official disallows the basket and uses the alternating possession arrow to resume play. Is the official correct? | 47. Yes | No |
| 48. A-1, while airborne, deflects a pass to the floor, returns to the floor, catches the ball and then starts a dribble. The official rules a legal play. Is the official correct? | 48. Yes | No |
| 49. A-1 is bleeding. The official stops play and directs A-1 to the bench. Team A has no 60 second time-outs remaining but has one 30 second time-out. The coach wants to use the 30 second time-out to keep A-1 in the game. The official rules a 30 second time-out may not be used to keep A-1 in the game. Is the official correct? | 49. Yes | No |
| 50. Team A is granted a time-out. As A-1 is heading to the bench area, A-1 is charged with a technical foul. The official rules A-1 is bench personnel and charges an indirect technical foul to the head coach. Is the official correct? | 50. Yes | No |
| 51. A-1 and A-2 are wearing black tights. A-2 is wearing a blue headband and wristband the same color as the team jerseys. The official rules A-2 cannot play wearing the blue headband and wristband and rules that the headband and wristband must be the same color as the tights. Is the official correct? | 51. Yes | No |
| 52. Thrower-in A-1 places the ball through the boundary line plane. B-1 fouls A-1. The official rules a common personal foul. Is the official correct? | 52. Yes | No |
| 53. A-1, while airborne, catches a pass and throws the ball to the floor. A-1 returns to the floor, catches the ball and then starts a dribble. The official rules an illegal dribble. Is the official correct? | 53. Yes | No |
| 54. During an alternating possession throw-in by Team A, a double personal foul is charged. The official charges the fouls and awards the ball back to Team A and rules this is still an alternating possession throw-in. Is the official correct? | 54. Yes | No |
| 55. During multiple substitutions for both teams, A-5 believes he/she has been replaced and goes to the bench as the ball is put into play. As the ball is being advanced up court, the coach now realizes he/she has only four players on the floor. The coach yells to A-5 to get into the game. A-5 runs onto the court. The official seeing A-5 enter the court assesses A-5 with a technical foul. Is the official correct? | 55. Yes | No |
| 56. Airborne shooter A-1 releases the ball on a try for goal and then time expires. While the ball is in flight, B-1 fouls airborne A-1. The try is unsuccessful. The official awards A-1 two free throws. Is the official correct? | 56. Yes | No |
| 57. During a throw-in, A-2 catches the ball while airborne. A-2 lands simultaneously on both feet. The right foot lands on the division line and the other foot in the frontcourt. The official rules a backcourt violation. Is the official correct? | 57. Yes | No |
| 58. Thrower-in A-1 passes the ball to A-2. A-2 catches the ball and passes it back to A-1 who has one foot touching inbounds and the other foot in the air over the boundary line. The official rules A-1 is out of bounds. Is the official correct? | 58. Yes | No |

59. Yes No 59. As the lead official bounces the ball to A-1 for his/her first free throw and before A-1 catches it, B-1 steps into the lane and requests a time-out. The official denies the request. Is the official correct?
60. Yes No 60. As time expires for the first extra period, the coach of Team B is assessed with a technical foul. Before the free throws are administered, Team B requests a time-out which is granted. After the unsuccessful first free throw, Team A requests a time-out. The official grants the request stating that the 2nd time-out is not a successive time-out because the ball became live between the requests. Is the official correct?
61. Yes No 61. A-1's throw-in is caught by B-2, who has one foot on the sideline. The official rules a violation on B-2 and awards Team A the ball out of bounds at the spot where B-2 caught the ball. Is the official correct?
62. Yes No 62. A-1, in the frontcourt, passes the ball to A-2, who is in the frontcourt. A-2 muffs the ball. The ball hits an official who is standing on the division line and rebounds back to A-2, who catches it without the ball touching the floor. The official rules a backcourt violation on Team A. Is the official correct?
63. Yes No 63. During a jump ball, jumper A-1 taps the ball to A-2, who is airborne from the frontcourt. A-2 catches the ball and throws it to A-3 in the backcourt. The official rules a backcourt violation. Is the official correct?
64. Yes No 64. While the ball is live, A-1 and B-1 begin to fight. The head coach enters the court to help restore order and prevent the situation from escalating. The official rules a double flagrant personal foul and rules the head coach is allowed on the court without being beckoned when a fight has broken out. The coach is not charged with a flagrant technical foul. Is the official correct?
65. Yes No 65. A-1, who has completed his/her dribble, passes to A-2. A-2 is unable to catch the ball and taps it back towards A-1. A-1 recovers the ball and starts a new dribble. The official rules a legal play. Is the official correct?
66. Yes No 66. A-1's pass from A's backcourt hits a teammate who is in the frontcourt. The ball rebounds into the backcourt and is first touched by A-1. The official rules this is not a backcourt violation because there was no player control in the frontcourt. Is the official correct?
67. Yes No 67. Shooter A-1 is fouled after time has expired and before the ball is released. The official rules the foul was not flagrant or intentional and ignores the foul. Is the official correct?
68. Yes No 68. A-1's throw-in lodges between the backboard and the ring. The official resumes play using the alternating possession procedure. Is the official correct?
69. Yes No 69. Player A-1 releases the ball on a try for goal. While the ball is in flight, a double foul is charged to A-2 and B-2. The ball rebounds off the ring and contacts an overhanging wire directly above the basket. The official awards a throw-in to Team B on the end line. Is the official correct?
70. Yes No 70. While the ball is at the disposal of A-1 for a free throw, A-2 fouls B-2. Team B is in the bonus. The official awards B-2 a one and one. Is the official correct?
71. Yes No 71. While A1 is in the act of shooting, B-2 pushes A-2 knocking A-2 into A-1. A-1 continues the try. Ball enters the basket. The official charges B-2 with a common foul on A-2 and counts the goal. Is the official correct?
72. Yes No 72. During an alternating possession throw-in, A-1 places the ball through the plane of the boundary line. B-1 grabs the ball and a held ball is ruled. The official awards the ball to Team B ruling that when the ball was touched while over the line, the throw-in ended. Is the official correct?
73. Yes No 73. Team A is charged with a technical foul. B-6 replaces B-1 to attempt the free throws. Following the attempts and while B-2 has the ball for the throw-in, the timer erroneously starts the clock and it runs for two seconds. The official sounds the whistle to stop the clock. The official puts the consumed time back on the clock. B-1 reports to replace B-6. The official beckons B-1 to enter. Is the official correct?
74. Yes No 74. Just as A-1 releases his/her free throw, B-1, in a marked lane space, steps into the lane to box-out A-1. In so doing he/she steps across the free throw line and fouls A-1, not intentionally nor flagrantly, before the ball hits the ring or backboard. The try is unsuccessful. The official charges B-1 with a free throw violation and a common foul. Is the official correct?
75. Yes No 75. While the ball is at the disposal of A-1 for a throw-in, there is team control. Is the official correct?
